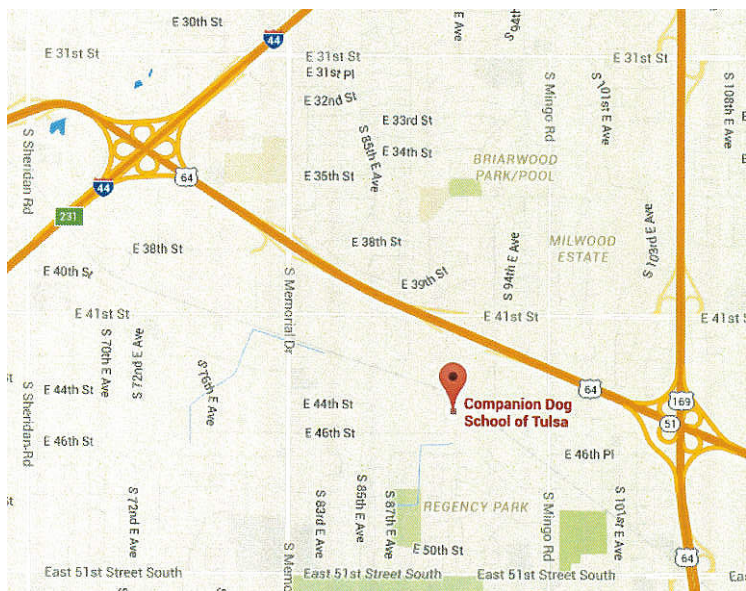
Due to a rental agreement with the facility, exhibitors will NOT be allowed to "chalk" or "powder" their dogs inside the building.

## Show Tours & New Exhibitor Orientation

Tours and an explanation of the inner workings and happenings at a dog show from the visitor's perspective will be held immediately following Sweepstakes judging on Saturday. How It All Works 101 - An informative session for the new exhibitor will be held immediately following the Show Tour.

## The following information will be the same for all shows:

### ATTENTION EXHIBITORS

The Show room will be available to exhibitors at 8:00 am Sat., October 19, 2019. Show room will be closed one hour after completion of Best of Breed until 8:00 am on Sunday. All dogs and equipment must be removed from the show site immediately following each day. A crating area will be available, NO CRATES ALLOWED RINGSIDE. Please use a drop cloth under your grooming area to protect the special flooring from grooming products.

Parking is very limited and there is no place to park RVs.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs must be ready for judging. The clubs will not be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The Clubs reserve the right to substitute a prize of equal or greater value. All trophies must be claimed the day of the show - none will be mailed.

Bred-By-Exhibitor Eligibility 1) All dogs entered in the Bred-By Class must be individually registered with the AKC. 2) The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. 3) To exhibit in this class, family members must be a breeder and owner of record.

RETURNED CHECKS do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.

No entry fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbance, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the clubs.

The show giving Clubs, their agents, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.

## AGREEMENT

I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" and, if this entry is for an obedience trial the "Obedience Regulations," have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

## INSTRUCTIONS

1. (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color). Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.). Dachshunds (long haired, smooth, wirehaired), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard), Collies (rough, smooth).
2. The following Categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rules refer to Chapter 14, Section 3).
